## Emergency Medical Technician - Hybrid Course

Northwest Iowa Community College brings a hybrid option to EMT candidates. The students will be required to attend some all-day Saturday sessions (8:00am–5:00pm) in order to complete the required skills, practice and competencies. This course will cover the 2019 EMT Scope of Practice changes. **Need-based tuition assistance is available.**

Modules presented include: Preparation of the EMT; Airway Management; Patient Assessment; Medical/Behavioral Emergencies; OB/GYN; Trauma; Infants and Children; Ambulance Operations, and additional skills. Clinical time is required in addition to the classroom hours. College credit is available. **Minimum class size of 6 is required.**

**Prerequisites:** Must be 17 years old at the start of class, be proficient in reading, writing, and speaking English, and physically capable of performing basic EMT skills. The student **MUST** have access to high speed internet at their residence to take this course. **The student must bring a credit or debit card to the first class for completion of the on-line background check.**

### Child Care Pediatric First Aid

The Heartsaver Pediatric First Aid Course will teach rescuers the knowledge and psychomotor skills they'll need to recognize emergencies at the work site and provide proper first aid.

The training will center on bleeding, head injury, fainting, diabetes, heart attacks, burns, and other types of medical or trauma emergencies. The American Heart Association Curriculum includes video-based training for consistency among the training. This course also provides training on Adult and Pediatric CPR and AED. ### Basic Life Support Provider CPR Course

This class covers the current 2020 American Heart Association guidelines for the Healthcare Provider certification level. The class covers the Automated External Defibrillator (AED) and the use of the bag-mask device. Techniques for CPR covered one and two rescuer CPR for the adult, child, and infant. Foreign Body Airway Obstruction techniques have been performed for all age groups. The participants have passed the written exam with a minimum of 84% in addition to completing all of the skills testing stations. Instructor: Jeana Wollmuth

## 75 HOUR CERTIFIED NURSE AIDE

This course is 75 hours in length and meets the requirements for taking the Nursing Assistant Certification Exam, which qualifies personnel to work as a nursing assistant in Long Term Care. The purpose of the course is to develop the basic skills to care for the elderly. This course consists of 30 hours of lecture, 15 hours of simulated lab time, and 30 hours of clinical.

**This course offers 3 hours of college credit.**

Uniform/scrubs, closed-toe shoes, and a watch with a second hand are required for the clinical portion of the course. Criminal background checks will be completed prior to the first class.
